



# SUPPLEMENTARY REGULATION

## Series 2019 I.R.C.

### Art.1- INSTITUTION AND CALENDAR

IRC Sport with registered in Bedonia (PR) 43041 Loc. Follo n.26, holder of the promoter license number **301906**, call a series composed by International Rallies denominated "INTERNATIONAL RALLY CUP", hereinafter referred to as I.R.C., which is based on the following events:

### Art.2- COMPETITORS AND DRIVERS ADMITTED

At I.R.C. are admitted all drivers in compliance with the F.I.A. and/or A.C.I..

The terms "COMPETITOR and/or DRIVER" means "1<sup>st</sup> Driver" this must result from the official rankings of each race.

The I.R.C. reserves the right to evaluate the applications for registration received. In case of non-admission the interested party will be informed in writing (by registered post) motivating their exclusion. The communication will take place no later than 10 (ten) days following receipt of the registration form and the registration fee will be refunded; in the same terms the same communication will be forwarded to AcI Sport, in such a way that the President AcI can decide on any disputes. The non admission of an application for registration gives the possibility to the competitor to appeal to the AcI Sport bodies, as provided for by the R.S.N. AcI Sport .

### Art.3- CARS ADMITTED

## Waiting final ACI Sport approval

At the races I.R.C. all the cars envisaged by the General Rally Sector and by the "International Non-Securitized" Sector Regulations may be admitted.

### **Art.4- POINTS**

The final rankings will be drawn up considering a maximum of 4 (four) results (with the exception of the "R2B Peugeot" class, which will be established by adding the 3 (three) best results, one of which will be the result obtained in last round regularly disputed of the calendar).

The points provided for each race are:

The score will be awarded according to the official FINAL CLASSIFICATION of each race, except as provided by the art. 11 of this regulation.

The scores will be multiplied by the coefficient of each race.

### **POWER STAGE**

The following points will be awarded for each grouping of Classes on a special stage of each race.

The Power Stage will be communicated to all entrants of I.R.C. at the Sporting Checks.

Points: 1<sup>st</sup> of grouping of classes p.ti 5

2<sup>nd</sup> of grouping of classes p.ti 3

3<sup>rd</sup> of grouping of classes p.ti 2

In the event that the Power-Stage is not disputed by the entire class (or grouping of classes), no score will be awarded. The points acquired in the Power-Stage will be added to the points acquired at the end of the Series without any difference.

The points for the compilation of the rankings will be assigned only to those in good standing with the registration in the "I.R.C.2019" Series.

In case of interruption of an event, the score will be assigned in the following ways:

- Over 30% of km of special stages carried out will be given the full score.

### **Art.5- FINAL PRIZES**

The awarding of the FINAL PRIZES will take place at the end of the 5 (FIVE) races and during the Awards Ceremony of the Series I.R.C. 2019 that will be communicated through the website [www.ircup.it](http://www.ircup.it)

#### **Art. 5-1**

The value of the cash prize will be considered valid, in its entirety, to the minimum achievement of 5 (five) members of the Series for each class; otherwise, the prize pool itself will be halved.

The Final Prize is CUMULABLE.

Binding condition for the allocation of prize money, is the participation in the last race of the I.R.C. calendar. 2019 regularly disputed.

### **Art.6- FUEL**

## **Waiting final ACI Sport approval**

With reference to the assignment of the score, binding condition will be the use, throughout the race, of the PANTA fuel distributed at the plant installed in the refueling area. It is mandatory to refuel PANTA at each refueling, under penalty of exclusion of the competitor from the acquisition of the race points.

The exclusive use of PANTA fuel is compulsory for all participants (enrolled or not to the I.R.C. 2019 series) to the races valid for I.R.C. 2019, and to the national ones that take place at the end of the same; this obligation is dictated by security reasons.

### **Art.7- TYRE**

With reference to the assignment of the points, the binding condition will be the use, during the entire race of PIRELLI tires, provided by the following AUTHORIZED RETAILERS:

that have been identified by IRC Sport as "OFFICIAL SUPPLIERS of the IRC 2019 Series".

As for the fuel it is mandatory to use only Pirelli tires purchased directly on the race field from the above-mentioned dealers. The non-acceptance of this condition will exclude the competitor from the acquisition of the race points.

### **Art.8- ENTRANCE FEE**

In order to participate in the I.R.C. Series, the holders of the Driver License as per Art. 2 must complete and sign in all its parts the appropriate registration form, published on the site [www.ircup.it](http://www.ircup.it) and send it, with attached the receipt of the bank transfer related to the registration fee, to:

At each competition, together with the entry list, the list of IRC entrants entitled to the scores will also be published.

### **Art.9- RANKING AND COMPLAINTS**

Regarding the final rankings, in case of a tie, the prize will be awarded to the driver who will have the best placement in the IRC Overall Classification. In case the ex-equu persists, the best placement on the first Special Stage will be taken as discriminating by both competitors.

After each race the IRC rankings will be updated, the Overall rankings and those of the various Classes and communicated via the website of [www.ircup.it](http://www.ircup.it)

With regards to complaints, the terms are those provided for by the R.S.N. 2019 edition.

### **Art.10- ADVERTISING**

Drivers participating in the IRC Series are obliged to affix, on their cars and in the spaces shown in the attached diagram, the official IRC stickers that will be awarded to them race by race.

By way of the foregoing, IRC Sport may request the Conductor registered in the Series for photographic or video material that proves the application of the above-mentioned official IRC stickers,.

IRC Sport may nominate, at each race, a person who will verify the regular position of the stickers.

In case of missing, partial or incorrect application of a single IRC official sticker on the car, no score will be assigned to the Competitor of the race in question.

The IRC Series participants are obliged to affix the "IRC Pirelli" parasol strip to the vehicle. (see Annex 1)

In the event that the COMPETITOR thinks he does not want to affix the stickers of the Series, to be exempted, he must send IRC Sport, by REGISTERED POST 30 days before the opening of the competition, a WRITTEN REQUEST accompanied by the payment of a fee EQUAL to 4 (four) TIMES THE VALUE OF THE REGISTRATION FEE to the IRC Series.

### **Art.11- DISCIPLINARY NORM**

The competitors and drivers registered in the series, undertake to carry out their activities with loyalty, correctness, dignity and decorum, in the protection of their reputation and image of IRC Sport.

They undertake to avoid any excessive and / or improper behavior that may damage the image and / or reputation of the other competitors / registered drivers and organizers

In the event that the Competitor violates the sporting and behavioral rules laid down in articles 7-8 of the R.S.N. Aci Sport and for this reason was sanctioned by the College of Sports Commissioners, the IRC can EXCLUDE the same from the Series with the immediate loss of the points acquired and the registration fee.

If behaviors that may damage the image and / or reputation of competitors and / or IRC Sport, without being sanctioned by the College of Stewards, the latter may impose, at its sole discretion, one of the following sanctions:

- loss of race points
- loss of all points
- exclusion from the IRC Series

### **Art.12- Final norm**

For anything not provided for by the present Regulations, reference is made to the sports regulations reported on the ANNUAL REGULATIONS of Aci Sport 2019.
